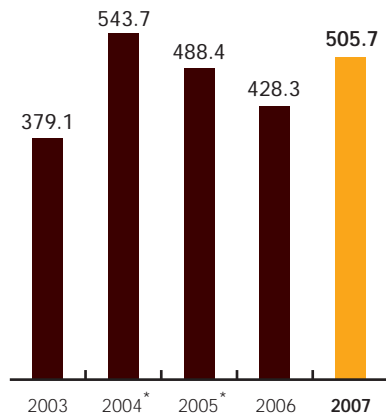

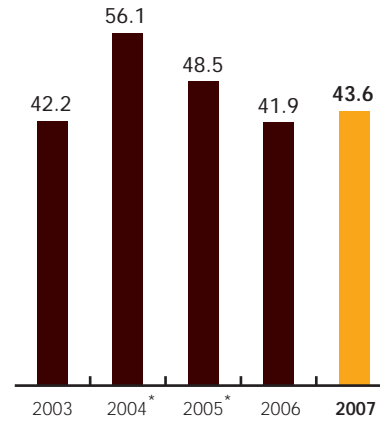

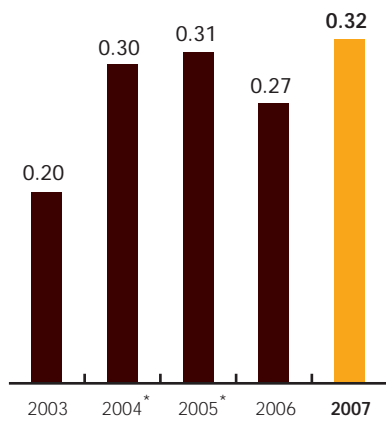
After-Tax Profit (S\$'m)



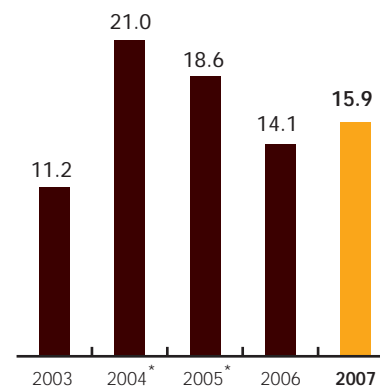
Return on Operating Revenue (%)



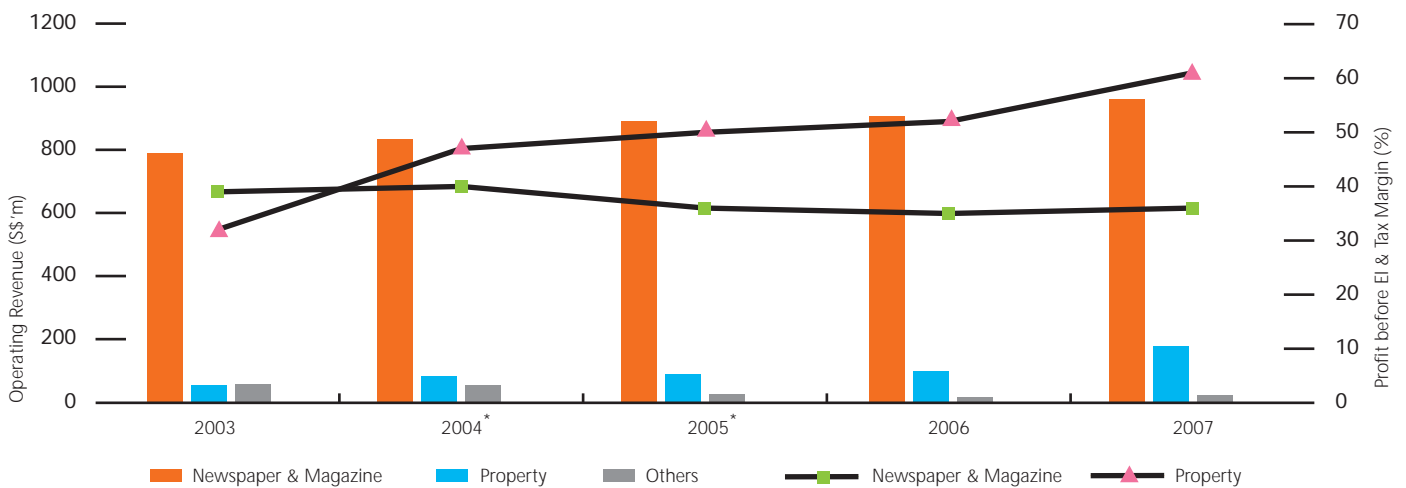
Earnings Per Share# (S\$)

Segmental Operating Revenue and Segmental Profit Margin



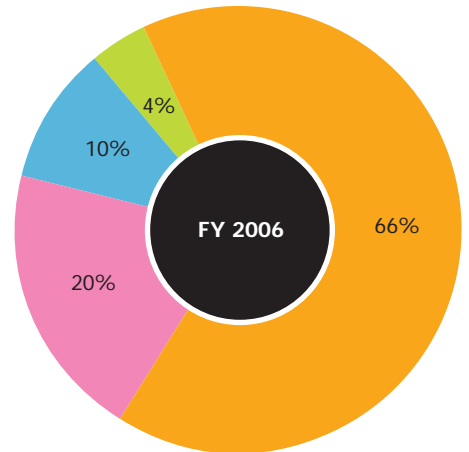
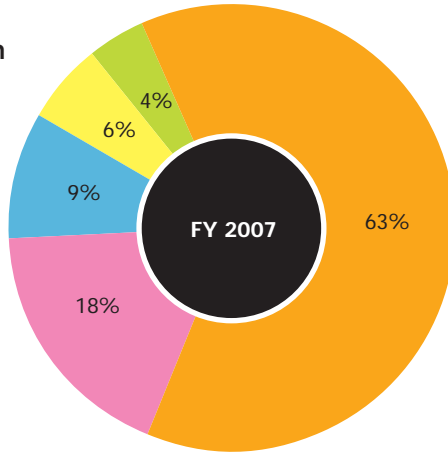
